

Permission to order an EU Disability Card

(i) When you apply for permission to order an EU Disability Card, Kela will check that you have a decision giving you eligibility for the card. You can get an EU Disability Card only if you have received one of the following decisions and the decision is in force on the day when Kela receives the application for permission to order the card:

Benefit decisions made by Kela:

- Disability allowance for children under 16 years of age
- Disability allowance for persons aged 16 years or over
- Care allowance for pensioners
- Interpreter assistance for persons with hearing impairment (A)
- Interpreter assistance for persons with hearing and vision impairment (A)
- Interpreter assistance for persons with a speech impairment (A)

Other decisions:


- Decision on daytime activities outside the home provided under the Act on Services for Persons with Disabilities
- Decision on transport services provided under the Act on Services for Persons with Disabilities
- Decision on mobility assistance (transport services) provided under the Social Welfare Act
- Decision on travel companion service (A)
- Vision Impairment Card (A)
- Agreement on informal care (the Disability Card is issued to the person cared for by an informal caregiver) (A)
- Decision on assisted living under the Act on Services for Persons with Disabilities (A)
- Decision on personal assistance provided under the Act on Services for Persons with Disabilities (A)
- Decision and services based on a special care programme (A)
- Decision on special support (A)
- Decision on respiratory paralysis (A).

The letter A at the end of the name of the decision means that you are entitled to a symbol A on the Disability Card on the basis of this decision.

This form and its enclosure as well as the processing of the application in the ordering system result in two personal data registers. One register is formed at Kela and one at the administrator of the card ordering system, i.e. the Disability Card Office (www.vammaiskortti.fi).
